According to the power entrusted to Point Pedro Urban Council under Urban Council Ordinance No. 61 of 1939 (Chapter 255) by the Section 166. Point Pedro Urban Council has to collect property tax from the houses, buildings, lands and small huts. The 1st Quarter property tax for each property is twelve percent (12%) and next three quarters are ten percent (10%) of the estimated value of the property further, for the year 2019 according to the detail given below in every quarter the tax entitle for that quarter should be paid to the Urban Council. Further according to the table below ; for every quarter the tax should be paid by the tax payer. If the tax is paid by the tax payer before the date in the third column five percentage 5% discount will be given by the Urban Council. But on the other hand if the tax is not paid by the taxpayer for the respective quarter before the respective date then for the bare lands and the houses the tax payers should pay fifteen percentage (15%) in excess. In the meantime the fine for business places is twenty percentage (20%).
